**ENTREPRENEURSHIP TRAINING OF FIRST YEAR CAREER PATHWAYS
IN TECHNOLOGY AND LIVELIHOOD EDUCATION (CP-TLE) TEACHERS
IN THE CHILD-FRIENDLY SCHOOL SYSTEM (CFSS)**

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

1. The International Labour Organization (ILO), Subregional Office for South-East Asia and the Pacific (SRO-Manila) with office address at Yuchengco Tower, RCBC Plaza, Ayala Avenue, Makati City in collaboration with the Department of Education (DepEd) through the Bureau of Secondary Education (BSE) shall conduct an **Entrepreneurship Training of First Year Career Pathways in Technology and Livelihood Education (CP-TLE) Teachers in the Child-Friendly School System (CFSS)** on August 5-9, 2010 at Cebu Business Hotel, Cebu City.

Traveling expenses and per diems of participants and management staff, professional fee for service/training providers, supplies and materials and all other expenses related to the training shall be charged against ILO Fund through direct payment modality subject to the usual accounting and auditing rules and regulations.
