Prospective bidders must have completed a similar contract within the last ten (10) years from date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding is restricted to Filipino citizens / sole proprietorships, organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184.
