The Department of Education Central Office, through its Bids and Awards Committee (BAC) II, now invites bids for the completion of above-mentioned works. Bids received that exceed the ABC shall be rejected at bid opening. Bidder's must bid for both items. Bids submitted for one item only shall be rejected. Late bids shall be rejected. Evaluation and award shall be made as one package to one contractor.

Prospective bidders must have completed a similar contract within the last ten (10) years from date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding is restricted to Filipino citizens / sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184.
