INVITATION TO BID

The Department of Education intends to apply the sum of **Philippine Pesos Five Million Seven Hundred Twenty Eight Thousand and 00/100 (PhP 5,728,000.00)** being the total Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Laptop Computers for the Alternative Learning System e-Service**, as follows:

The Department of Education Central Office, through its Bids and Awards Committee (BAC) II, now invites bids for the above-mentioned goods. Late bids shall be rejected. Bids received that exceed the ABC shall be rejected at bid opening. Bidder must bid for all items, otherwise, the bid shall be rejected. Evaluation and award shall be made as one lot.

Prospective bidders must have completed a similar contract within the last three (3) years from date of submission and receipt of bids with an amount of at least 50% of the total ABC to be bid.

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.


Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of R.A. 9184.
