1. For the information and guidance of all concerned, enclosed is a copy of Commission on Elections (COMELEC) Resolution No. 9019 promulgated on August 31, 2010, entitled Calendar of Activities and Periods of Certain Prohibited Acts in Connection with the October 25, 2010 Synchronized Sangguniang Kabataan and Barangay Elections. In connection with this, please take note of the following date/period and prohibited acts:

DATE/PERIOD	PROHIBITED ACTS
September 25, 2010 (Sat) - October 25, 2010 (Mon)	Issuance of appointments, promotions, creation of new positions, or giving of salary increases in government offices, agencies and instrumentalities (Sec. 261 (g), OEC)
	Transfer and detail of officers and employees in the Civil Service, including including public school teachers (Sec. 261 (x), OEC)

2. The Schools Division/City Superintendents and Officer-In-Charge thereof are again hereby reminded to perform the following in accordance with existing laws, rules and regulations:

- a. Prepare and submit to the Election Officers (EO) of the names of the public school teachers recommended for appointment as chairmen and members of the Board of Election Tellers (BET's);
 - b. Prepare and submit to the Election Officers the names of district supervisors and/or school principals recommended for appointment as team leaders who will monitor their respective precincts; and
 - c. Comply strictly with the rules and regulations prescribed therein and such other resolutions as may be promulgated by the Commission on Elections.
3. Please remind and instruct all our public school teachers who will be performing the solemn and sacred duty of ensuring the integrity of the Synchronized SK and Barangay Elections, as chairmen and members of the Board of Election Tellers (BET's) and of the different Barangay Board of Canvassers (BBC's), to discharge their duties with utmost competence and impartiality.
 4. Immediate dissemination of this memorandum is hereby directed.


