HOSTING OF THE SIXTH ASEAN SCHOOLS GAMES (ASG) AND CREATING THE ASG-GOVERNING BOARD, DEFINING ITS FUNCTIONS AND COMPOSITION

1. As one of the member-nations of the ASEAN Schools Sports Council (ASSC) and pursuant to its international commitment to the ASSC, the Regional Office of the Department of Education (DepEd), National Capital Region (NCR) and the City Government of Marikina shall host the **Sixth ASEAN Schools Games (ASG)** from November 29 to December 7, 2014 in Marikina City.
2. The ASG aims to:
 - a. promote ASEAN solidarity among the youth through school sports;
 - b. provide them with opportunities to benchmark their sporting talents in the ASEAN region; and
 - c. provide them with opportunities to interact and engage in cultural exchange within ASEAN.
3. In fulfilling this commitment, a steering group to be known as the Sixth ASG Governing Board (ASG-GB) is hereby created. The composition and terms of reference are as follows:

The ASG-GB shall:

- a. provide the general directions in planning, organizing and implementing the hosting of the ASG;
- b. provide the general supervision in the conduct of the games;
- c. approve the creation and organization of the different working committees and designate committee heads; and
- d. exercise other functions or responsibilities as maybe directed by the Secretary of Education.

The Sixth ASG-GB shall immediately convene and formulate the necessary course of action, and corresponding activities, and shall prepare both technical and administrative requirements.

4. The DepEd-NCR Office and all its schools division offices shall provide assistance and support to the City of Marikina as the host in the fulfillment of its obligation.


5. The participating ASEAN countries are Brunei, Indonesia, Singapore, Malaysia, Thailand, Laos, Vietnam and the Philippines.

6. There shall be 11 sports to be played; namely, athletics, swimming, badminton, golf, *sepak takraw*, gymnastics, table tennis, tennis, basketball, volleyball and *wushu*. The competitions shall be governed by their respective international rules and regulations unless otherwise amended or revised by the Organizing Committee with concurrence of the participating ASEAN countries.

7. A Selection Committee shall be formed to identify and select the best athletes who will represent the Philippine delegation among the student-athletes from private or public schools. Priority shall be given to those who joined the recent 2014 *Palarong Pambansa*.

8. Further, the meeting of the ASEAN Country Chef de Mission Representatives shall be held on **September 10-13, 2014** at a hotel venue to be announced later.

9. Expenses such as board and lodging, transportation expenses, rental of service vehicles, uniforms, sports equipment, supplies and materials, souvenirs, training allowance, honoraria, and other incidental expenses necessary for the successful conduct of this project shall be charged to OSEC-GASS Funds, subject to the usual accounting and auditing rules and regulations.
10. Immediate dissemination of this Memorandum is desired.
