## 5<sup>th</sup> NATIONAL CONVENTION ON DEAF EDUCATION AND AWARDING OF OUTSTANDING TEACHERS OF THE DEAF

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Private Elementary and Secondary Schools Principals

- 1. The Department of Education, Bureau of Elementary Education through the Special Education Division in coordination with Christoffel Blindenmission (CBM) International and the National Association of Special Educators (NASE), Inc. will hold the Fifth National Convention on Deaf Education on 14-16 May 2003 at the VIP Hotel, Cagayan de Oro City. The theme of the convention is "Accessibility, Curricula, and Technology for the Deaf."
- 2. The convention aims to gather persons who are deaf, those who have deaf family members, and those who are for and with deaf persons in their lives or in their work. It will further provide opportunities for participants to:
  - a. share their insights on deaf education;
  - b. make a difference in the deaf community;
  - c. keep abreast of the technology for the deaf; and
  - d. recognize the 2003 Outstanding Teachers of the Deaf.
- 3. Participants shall include deaf students, parents, professionals, teachers of the deaf, service providers for the deaf, school administrators and supervisors, superintendents, supervisors in-charge of SPED, Chiefs/Assistant Chiefs of Elementary and Secondary Education Divisions.
- A registration fee of One Thousand Seven Hundred Pesos (P1,700) shall be charged each participant which shall include lunch and snacks for three (3) days, conference kits, handouts and certificates. Parents of the deaf and deaf students/professionals shall pay One Thousand Five Hundred Pesos (P1,500) only.

5. Lodging is not included in the registration fee. Participants have the option to choose their own accommodations. Below are some choices:

RELC - P245 - P290/day - Board & Lodging (100 persons)
Blessed Child
Academy Dormitory - P100/day- Lodging only (100 persons)
The VIP Hotel - P290 - P350/day- Lodging only

- 6. Pre-registration is encouraged to facilitate the preparation of materials and should be sent to: Special Education Division, Bureau of Elementary Education, 2/F Bonifacio Building, DepEd Complex, Meralco Avenue, Pasig City. The pre-registration form is found in Inclosure No.1
- 7. Expenses incident to the participation of DepEd teachers, administrators and other officials shall be charged to local funds. Participants from private institutions shall make their own financial arrangement with their respective offices.
- 8. Immediate and wide dissemination of this Memorandum is desired.
