GUIDELINES IN THE UTILIZATION OF THE SUBSIDY FOR THE REGIONAL SCIENCE HIGH SCHOOLS FOR CY 2003

To: Undersecretaries
Assistant Secretaries
Bureau Directors
Regional Directors
Schools Division/City Superintendents
Regional Science High School Principals

- 1. For CY 2003, all Regional Science High Schools (RSHSs) shall be given Two Million Pesos (PhP2,000,000.00) each in two installments at One Million Pesos (PhP1,000,000.00) each installment for specific purposes under budget line for Maintenance and Other Operating Expenses (MOOE).
- The utilization of the said amount shall follow these specific guidelines:

25% or Php500,000.00 - Procurement of supplies and materials for Science, Mathematics and English only;

20% or PhP400,000.00 - Procurement of instructional materials including textbooks/reference books for each subject area, professional books, CDs in Science, Mathematics and English including

internet subscription;

30% or PhP600,000.00 - For electric and water bills, maintenance and repair of previously owned science and mathematics equipment including upgrading

of computers/printers;

12.5% or PhP250,000.00 - For expenses for training/professional

upgrading of all teachers/principals/OICs directly managing the RSHSs, including attendance in seminars that may be sponsored by DepED or other agencies; and

12.5% or PhP250,000.00 - Subsidy for student researches/projects.

3. The first installment of One Million Pesos (PhP1,000,000.00) shall be released to the DepED Regional Offices in the form of Sub-Allotment Release Order (Sub-ARO) as follows:
