NATIONAL FORUM FOR SCHOOL HEADS

1. The Department of Education (DepED), through the Curriculum Development Division, Bureau of Secondary Education (CDD, BSE), in collaboration with Intel Technology Philippines, Inc. (ITPI), and SEAMEO INNOTECH will conduct a two-day National Forum for School Heads, with the theme "Technology Use in the Classroom: The School Head as Advocate" at the Pearl Hall, SEAMEO INNOTECH, Commonwealth Avenue, Diliman, Quezon City. This Forum will be conducted in two (2) batches as follows:

- 2. The National Forum aims to discuss the school head's role in ensuring the optimal use of technology in achieving better learning outcomes. It shall enable the participants to:
 - examine their capabilities, explore certain possibilities, share common problems and successes, and generate new ideas and plans for integrating ICT in the classroom through the Intel Teach to the Future Program; and
 - b) develop a strong sense of commitment to implement the Intel Teach to the Future Program and plan for successful project start-up in the next 3 years in their respective schools.
- 3. The participants to this Forum shall be selected school heads of the recipient-schools under the PCs for Public Schools Project Phase 2 (PCPS 2). Other participants are two specialists from the Bureau of Secondary Education (BSE) and the Regional IT Coordinators. Their attendance shall be on **official business**.
- 4. Selection of the school head-participants will be done by the Regional IT Coordinator who will determine who has the most need for the experience and exposure. The allocation of slots per region is contained in the Enclosure.
- 5. Intel Technology Philippines, Inc. (ITPI) shall subsidize the cost of participation in the forum including meals and accommodation at SEAMEO INNOTECH, Travel expenses of the participants shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
