PAYMENT OF THE REMAINING UNPAID PER DIEMS OF DEPED PERSONNEL ASSIGNED POLL DUTIES IN THE MAY 10, 2004 NATIONAL AND LOCAL ELECTIONS

To: Regional Directors Schools Division/City Superintendents Heads, Public Elementary and Secondary Schools

- The documents to cover the release of funds to pay the remaining unpaid per diems of DepED personnel assigned poll duties in the May 10, 2004 elections are now being prepared/ processed by the Department of Budget and Management (DBM) and we are expecting that in a couple of days DepED will be receiving the said funds.
- The cash allocations will be released thru the respective DepED Regional Offices 2. (ROs) which will transfer the same to the Schools Division Offices (SDOs).
- Any excess in the amount earlier released for the advance payment of the two-day per diem vis-à-vis actual disbursements made thereof shall be used to cover partial payment of the remaining P1,000.00 and P500.00 per diem of BEIs and election supervisors, and their support staff, respectively.
- This is to reiterate, however, the submission of reports to the Budget Division, this Department (c/o Mr. Armando C. Ruiz) on the actual disbursements made on the following using Form "A" hereto attached:
 - a) Advance payment of two-day per diems; and
 - b) Payment of the remaining per diems.

- 5. The funding requirement for the payment of overtime services rendered by members of the Board of Canvassers (BOIs) and their support staff shall be based on actual election duties to be submitted also to the Budget Division using Form "B". The report is needed by the said Office to serve as basis in the release of funds for the purpose.
- 6. Please be reminded that payments out of the funds released thru DepED Regional Offices shall be limited only to DepED personnel and locally-funded teachers who served in the May 10, 2004 elections as members of BEIs, BoCs, supervisors and support staff per item 2.j of DepED Memorandum No. 182, s. 2004.
- 6. Immediate dissemination of this Memorandum is desired.
