> NATIONAL ORIENTATION-WORKSHOP ON THE ALTERNATIVE LEARNING SYSTEM (ALS) FOR NONFORMAL EDUCATION (NFE) REGIONAL AND DIVISION SUPERVISORS

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents

- 1. The Bureau of Nonformal Education (BNFE), this Department, through the Continuing Education Division, will conduct a three-day Orientation-Workshop for NFE Regional and Division Supervisors at the Richville Hotel, EDSA, Mandaluyong City on July 13-15, 2004.
- 2. The general objective of this activity is to enhance the participants' supervisory skills on the new trends and developments in the implementation of the Alternative Learning System (ALS). It specifically aims to:
  - a. provide information on trends and developments in the two major programs, namely, the Basic Literacy Program (BLP) and the Nonformal Education Accreditation and Equivalency (NFE A&E) System;
  - b. discuss problems, issues and other program implementation concerns towards acceptable resolutions;
  - c. devise a periodic and effective monitoring, evaluation and reporting system at all levels for the ALS; and
  - d. raise the participants' level of commitment as program implementers of the ALS.
- 3. Each participant will be charged a registration fee in the amount of Four Thousand Five Hundred Pesos (PhP4,500.00) to defray expenses for board and lodging, handouts, training kits and other workshop supplies and materials. Payment of registration fee may be in cash or in check payable to the Bureau of Nonformal Education (BNFE). Registration fee, transportation and other expenses to be incurred relative to the supervisors' participation in this activity shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
- 4. Participants are requested to check-in at the workshop venue in the afternoon of Monday, July 12, 2004, and check-out after breakfast on Friday, July 16, 2004. Accommodations will be on a first-come, first-served basis.
- 5. Registration fees, transportation and other miscellaneous expenses of BNFE officials and staff relative to the conduct of same shall be charged against the bureau funds.
