2004 VOCATIONAL EDUCATORS SUMMIT

To: Regional Directors
Schools Division/City Superintendents

- 1. The Philippine Association for Vocational Education (PAVE) will conduct the 2004 Vocational Educators Summit with the theme "Strategic Positioning of Vocational Technical Education in the Knowledge-Based Economy" on December 6-8, 2004 at the Teachers Camp, Baguio City.
- 2. The summit will focus on:
 - a. identifying possible strategies to enhance the capabilities of technical-vocational schools to meet the opportunities and challenges in the emerging knowledge-based economy; and
 - b. promoting technical vocational education among the youth to build better education and adaptable workforce as enunciated by Her Excellency President Gloria Macapagal-Arroyo in her State of the Nation Address (SONA).
- 3.
