NATIONAL TRAINING ON THE IMPLEMENTATION OF THE REDESIGNED  
TECHNICAL-VOCATIONAL HIGH SCHOOL PROGRAM

To: Regional Directors  
Schools Division/City Superintendents  
Heads, Technical-Vocational High Schools

1. The Bureau of Secondary Education (BSE), this Department shall conduct a National Training on the Implementation of the Redesigned Technical-Vocational High School Program, which shall be held in two (2) clusters, as follows:

2. The training aims to:


- explain the guidelines in implementing the redesigned technical-vocational high school program;
- discuss the technical-vocational education in the context of the 21<sup>st</sup> century core skills;
- identify competencies in a workplace that can be integrated in the technical-vocational learning competencies;
- develop prototype lesson plans using integrated learning competencies; and
- apply appropriate methods/strategies in teaching lessons showing the process of integration.

3. The participants in the said activity are the school heads and department heads of Technical-Vocational High Schools, representing the four (4) types of school/curriculum per region, namely, Agriculture, Fishery, Trades and Home Economics, TLE/Technical-Vocational Regional Supervisors and three (3) division supervisors per region. The participants are expected to be at the venue at 1:30 p.m. of the first day of the training.

4. Registration fee, traveling expenses, and per diem of the participants shall be charged against local/school funds, while that of the training staff, supplies and materials, and other incidental expenses relative to the training shall be charged against BSE Project Funds, subject to the usual accounting and auditing rules and regulations.
