#### SCHOOL CELEBRATIONS OF SIGNIFICANT EVENTS

To: Bureau Directors
Directors of Services, Centers and Head of Units
Regional Directors
Schools Division Superintendents
Heads, Public and Private Elementary & Secondary Schools

- 1. In line with the DepED Order No. 9, s. 2005, "Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith", which aims to limit school celebrations to those events directly relevant to the instructional program, this Department hereby provides this list of events of historical, cultural and political significance which schools may wish to celebrate.
- 2. In general, discussions and/or conduct of a lesson-centered activity on the significance of said events should be integrated in related subject areas utilizing various strategies during the regular classroom instruction. The said integration should serve as the mode of imparting important messages to students.
- 3. For the events whose celebration is spearheaded by DepED, additional activities may include:
  - conduct of poster, slogan and essay writing contests on the theme of the significant event;
  - holding of symposia/lectures/ and other fora on topics related to the event and inviting speakers during the flag ceremony to talk about the significant celebration;

- putting up of bulletin board display in strategic places in the schools depicting the theme of the event;
- publication of relevant articles in the school newsletter explaining the historical/political/cultural significance of the event; and
- inviting civic spirited groups, associations and the like to render services to school children.
- 4. Enclosed is the list of school events for your information and reference.
- 5. Every School Head must send to the Division Office a letter acknowledging receipt of the DepED Memorandum including the date of receipt and committing to comply with its provisions.
- 6. Immediate dissemination of this Memorandum is desired.
