2005 DepEd Palarong Pambansa Technical Management and Games Administration

- 1. The 2005 DepEd Palarong Pambansa held in Iloilo City on 8 14 May 2005 is an inter-agency special project, conducted under the management of the Department of Education and in cooperation with the Provincial Government of Iloilo Province and the City Government of Iloilo City as hosts and the Philippine Sports Commission as technical adviser.
- 2. The technical aspect of the Palaro is vested on the Technical Management and Games Administration Committee, which is composed of Technical Secretariat, and the Technical / Officiating Officials, with local coordinators and volunteers augmenting the personnel structure of the Committee.
- 3. The Committee is headed by a Chairman who has a Vice Chairman and a Secretary General. The sub-committees are the Secretariat, Screening and Accreditation, Records and Documentation, Jury of Appeals, and the Officiating Officials of the different sports events. The sub-committees are headed by Chairmen, while each sports event is headed by a Tournament Director / Manager, and assisted by a Tournament Secretary.
- 4. Pursuant to its commitment for the hosting of the Palaro, the Provincial Government of Iloilo shall take care of the preparation of the playing and billeting venues of delegations and technical officials, and purchase of technical equipment. It shall also shoulder the expenses for the payment of honoraria of the officers and members responsible for the 2005 Palarong Pambansa Technical Management and Games

Administration, chargeable against the Special Education Fund (SEF), as agreed with DepEd inasmuch as the Palaro is a component of the physical education and school sports program under the Basic Education Curriculum.

- 5. The payment of honoraria is intended as compensation for services rendered beyond the regular functions of the government personnel and beyond the regular work hours. Technical officials who come from private organizations are recognized experts and/or accredited officials in their respective sports disciplines and shall also be entitled to honoraria as compensation for their professional services. The rates for honoraria have been set taking into account, among others, the extent of involvement, the technical expertise, and the degree of responsibility and accountability of the concerned personnel. The list of personnel and their corresponding honorarium is attached.
- 6. For information and guidance of all concerned.
