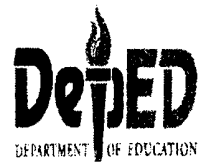

2. The said Enclosure is hereby corrected as follows:


