**ESTABLISHING THE TECHNICAL WORKING GROUP FOR THE DEVELOPMENT  
OF THE TEACHING EXEMPLARS AND STUDENT HANDBOOK  
ON THE RULE OF LAW**

1. Pursuant to Executive Order No. 361 entitled "Establishing the Policy of Promoting Awareness of and Respect for the Rule of Law in the Basic Educational System", the Department of Education (DepED) together with the Supreme Court and the Lawyers' League for Liberty (LIBERTAS) has conceptualized the Public Education on the Rule of Law Advancement and Support (PERLAS) Project.
2. The Project aims to educate students in public elementary and high schools, about the judiciary and the rule of law by means of teaching and learning methods that are appropriate and relevant to their respective learning competencies. 
