**CHANGES IN DEPED MEMORANDUM NO. 364, S. 2010
(2010 Conduct of Screening, Selection, and Regional Cluster Training
Workshops for Potential Textbook Evaluators)**

1. In preparation for the forthcoming procurement of various instructional materials for elementary *Musika, Sining, at Edukasyong Pangkatawan (MSEP)*, elementary *Edukasyong Pantahanan at Pangkabuhayan (EPP)*, high school *Science, English, Technology and Livelihood Education (TLE)*, and instructional materials for Technical-Vocational Schools, the Instructional Materials Council Secretariat (IMCS) has postponed the conduct of the Nationwide Screening, Selection, and Training-Workshop of Potential Textbook Evaluators announced in DepEd Memorandum No. 364, s. 2010.

2. The following changes are made in DepEd Memorandum No. 364, s. 2010:


- a. The activity which was scheduled in August 2010 will start in **April 2011** due to the unavailability of test items required in the screening of applicants;
- b. Screening of applicants in preparation for the evaluation of books for elementary *Edukasyon sa Pagpapakatao (EP)* will also be included in this activity;
- c. The designated Regional Textbook Evaluation Coordinators (RTECs) should submit the name of their Regional Coordinator for Elementary EP who will serve as member of the Regional Office Screening Team on or before **March 18, 2011**; and
- d. The RTECs shall submit the names of previously screened applicants for elementary *Musika Sining at Edukasyon sa Pagpapalakas (MSEP)*, elementary *Edukasyong Pantahanan at Pangkabuyahan (EPP)*, and high school *Technology and Livelihood Education (TLE)* and their respective specializations on or before **March 1, 2011**.



3. Designated RTECs shall continue accepting applicants in the abovementioned learning areas in their respective regions at least two weeks before the scheduled regional screening. Please refer to Enclosure Nos. 3A, 3B, and 3C of DepEd Memorandum No. 364, s. 2010 for the Criteria of Textbook Evaluators.
