- 1. The National Search Committee (NSC) is reconstituted to evaluate the candidates/applicants for the third level positions such as Regional Director (RD), Assistant Regional Director (ARD), Schools Division/City Superintendent (SDS) and Assistant Schools Division/City Superintendent (ASDS).

- 3. The NSC shall review the proposed National Search Process and other guidelines to ensure compliance with the Department's existing executive orders and other regulations on the selection and appointment of the third level positions. It shall submit shortlisted candidates and recommendations to the Secretary who shall make the necessary recommendations to the President of the Philippines.
- 4. The composition of the Regional Search Committee (RSC) shall be based on the provisions of DepEd Memorandum No. 366, s. 2010. The RSC shall perform the following functions:
 - a. Accept applications;
 - b. Profile professional qualifications based on
 - Education,
 - Training,
 - · Experience, and
 - Outstanding accomplishments;
 - c. Conduct initial interviews of applicants; and
 - d. Submit recommendations to the NSC together with supporting documents such as ranking and candidate portfolio.
- 5. Expenses to be incurred by the NSC such as professional fees for external members of the committee, and other incidental expenses shall be charged to HRTD Funds, while those incurred by the RSC shall be charged to local funds subject to the usual accounting and auditing rules and regulations. In this connection, the Regional Directors are hereby authorized to allocate funds for this purpose. This Memorandum will also serve as authority for the members of the NSC, RSC and candidates to attend activities related to the search process and to use local funds for their travelling expenses.
