**NASSPHIL NATIONAL EDUCATORS CONFERENCE AND TRAINING-WORKSHOP**

1. The National Association of Secondary Schools of the Philippines (NASSPHIL), Inc. will conduct the **2012 National Educators Conference and Training-Workshop** with the theme "*K to 12 Success: A Call for a Strong Partnership Among the General Public, Technical-Vocational and Private Education Sectors*" with the tag line "One Mind, One Heart, One Mission, One Philippines" on April 19-21, 2012 at the Royal Mandaya Hotel, Davao City.


