BASIC AND ADVANCE TRAINING OF TRAINORS (TOT) AND COACHES, AND TECHNICAL AND CLASSIFICATION SEMINARS FOR THE DIFFERENTLY ABLED PERSONS

1. The Philippine Sports Association for the Differently Abled, National Paralympic Committee of the Philippines (PHILSPADA-NPC Philippines) under the auspices and authority of the Philippine Sports Commission (PSC) in coordination with the Department of Education (DepEd) through the School Sports Events and Activities Unit (SSEAU) will conduct the **Basic and Advance Training of Trainors (TOT) and Coaches, and Technical and Classification Seminars for the Differently Abled Persons** on the following dates and venues:

2. The Training-Seminar aims to:

- create awareness of the sports program of the differently abled in the local/grassroots and in the national level;
- organize and train coaches and trainors in the proper system of coaching and training of differently abled athletes;

- c. establish a pool of coaches, trainers, technical officials and classifiers who will help the differently abled athletes in all levels of competitions;
 - d. identify the outstanding athletes;
 - e. install correct classification for virtually impaired and orthopedically handicapped athletes; and
 - f. form a national pool of differently abled athletes, duly recognized by PHILSPADA-NPC Philippines.
3. These activities will have three (3) components:
 - a. Training of the Trainers and Coaches;
 - b. Technical and Classification Seminars; and
 - c. Talent Identification.
 4. The participating athletes for the Talent Identification in Athletics, Swimming, Table Tennis, Goalball and Futsal, Boccia are those who are orthopedically handicapped and visually impaired. The training may be used by PHILSPADA-NPC Philippines as basis for the selection of Philippine Team for future international competitions.
 5. The DepEd Special Education (SPED) supervisors, teachers and coaches who served in the recently 2012 *Palarong Pambansa* held in Lingayen, Pangasinan are invited to attend this basic training-seminar.
 6. Participants for the advance course are those who attended the previous Training of Trainers and Coaches, and Technical and Classification Seminars for Differently Abled as per DepEd Memorandum No. 183, s. 2011 held last year. The list of participants is enclosed.
 7. The PHILSPADA-NPC Philippines shall provide for the board and lodging while the participants' transportation and other incidental expenses shall be charged to local funds subject to the usual accounting and auditing rules and regulations. Confirmation of attendance shall be made one (1) week before the schedule of the training.
 8. All participants (regional, provincial/city and municipal delegations) must bring their own sleeping materials, toiletries and sports attire. Classrooms from both public and private schools will be used for the accommodation of all delegates.
 9. The general guidelines and program of activities are enclosed.
