CREATION OF A TECHNICAL WORKING GROUP TO REVIEW AND REVISE POLICIES ON EDUCATIONAL FIELD TRIPS

To: **Undersecretaries Assistant Secretaries** Bureau and Service Directors Regional Directors Schools Division Superintendents All Others Concerned

- Due to the tragic bus accident that claimed the lives of college students during their field trip in Tanay, Rizal on February 20, 2017, the Department of Education (DepEd) instructed all public elementary and secondary schools to observe a moratorium as guided by DepEd Order Nos. 56, s. 2001; 51, s. 2002; and 53, s. 2003 in relation to the conduct of educational field trips.
- Pursuant to DepEd Memorandum No. 47, s. 2017 otherwise known as 2. Moratorium on DepEd Educational Field Trips and Other Similar Activities issued on March 9, 2017, the DepEd is creating a Technical Working Group (TWG) composed of the following bureaus and services:





- The TWG is instructed to convene immediately to review and revise all related 3. policies on educational field trips, particularly on the following areas:
 - a. Alignment of field trips and other co-curricular activities with that of DepEd's priorities;
 - b. Ensuring the security and safety of learners; and
 - c. Reinforcing the responsibilities and accountabilities not only of schools, but also of parents, and of other relevant government agencies and external partners.





- 4. The TWG shall submit policy recommendations prior to the opening of School Year 2017-2018.
- 5. The PRDD will act as Secretariat of the said TWG. Its functions include technical and administrative support to the committee, and perform such other functions as the committee may deem necessary.
- 6. Immediate dissemination of this Memorandum is desired.
