## 11th NATIONAL CONGRESS AND SEMINAR-WORKSHOP OF THE DEPED-NATIONAL EMPLOYEES' UNION

- The Department of Education-National Employees' Union (DepEd-NEU) will hold its 11th National Congress and Seminar-Workshop with the theme DepEd-NEU: A Partner of Management in Raising and Nurturing an Empowered Education Workforce for National Development from December 5 to 7, 2017 (exclusive of travel time) at the Baguio Teachers Camp, Baguio City.
- 2. The congress aims to:
  - refresh the participants and inculcate in them the necessary education, information, and awareness about raising and nurturing an empowered education workforce for national development;
  - b. provide them with knowledge on how to properly deal with, address, and extend help to resolve issues, conflicts, and problems brought about by the existence of problems in different workplaces and school campuses involving DepEd personnel and learners; and
  - assist in developing a social dialogue program for the Union to c. sustain a harmonious working relationship with DepEd management in order to secure better working relationship in the implementation of projects and programs.
- Participants to the congress are DepEd-NEU chapter executive officers in the regional, division, and school levels, who are all nonacademic rank-and-file employees of DepEd, including but not limited to, central, regional, division, and school administrative officers, human resource management officers/personnel officers, planning officers, legal officers, special investigation officers, information and communication technology personnel, supervisors, education program specialists, health and nutrition personnel, accountants, budget officers, supply officers, bookkeepers, administrative assistants, utility workers, administrative aides, and all other non-teaching personnel; members of the National Board of Trustees and National Executive Committee, chairpersons and members of the DepEd-NEU Secretariat, and steering committees. Attendance of the participants shall be on official business.

- 4. A registration fee of Four Thousand Eight Hundred Pesos (P4,800.00) shall be charged to each participant to cover expenses for the kits, board and lodging, honoraria of resource persons and facilitators, and other incidental expenses charged to local funds, subject to the usual accounting and auditing rules and regulations.
- 5. The members of the different working committees, the National Board of Trustees and National Executive Committee, shall be considered participants and shall pay their registration fees. They are authorized to travel two days before the start of the congress for the necessary preparations.
- 6. Arrival and registration shall be on **December 4, 2017** (Day 0). The first meal to be served will be dinner on the same day, while the last meal will be p.m. snack on the last day of the congress, **December 7, 2017**.
