This is to respectfully submit the report on school sites acquisition under the Special Provision No. 7 on Acquisition of School Sites in the General Appropriations Acts (GAAs) of 2016 and 2017 with a total amount of Php130,000,000.00(Php65,000,000.00 for FY 2016 and Php65,000,000.00 for FY 2017). The said budget, which is allocated as Capital Outlay (CO), shall be exclusively used for the acquisition of new school sites to address school congestion and pursuant to final decisions of the courts. Below is the table of the accomplishment in 2017 on acquisition of school sites:

The submission of the report is not in a quarterly format since the acquisition of new sites depends on the completion of the documentary requirements by the property owner and the Schools Division Office (SDO) concerned. Further, since the budget allocation on acquisition of

school sites is considered a contingent, it can be used only when there is a request from a Schools Division Office to acquire a property to address school congestion and when there is a final decision from the court directing the Department to pay the value of the property to the rightful owner of the contested school site.

In 2016, the Department had acquired the following properties to address congestion in schools in Quezon City, Cavite, and Bulacan:
