NATIONAL ANNUAL CONFERENCE OF THE NATIONAL ASSOCIATION FOR EARLY CHILDHOOD EDUCATION

- The National Association for Early Childhood Education (NAECE) will hold its annual conference with the theme "(Re) Kindling the Passion for Teaching" on May 1-3, 2003 at the Elpidio Quirino Hall, Teachers Camp, Baguio City.
- The conference aims not only at nourishing the head and heart of the early childhood educator but also touching the soul and spirit with commitment to teaching as the end in view.
- The conference will feature opportunities to: a) participate, share and learn in the formal sessions and lecture-demonstrations on instructional strategies, music and theater arts show, and sharing of best practices; b) be honored in non-traditional awards; and c) help build a network of early childhood education advocates and friends.

A participant gets a Two Hundred Peso (PhP200.00) discount as member of the association CY 2002 to present or in groups of ten from a division, the 10th participant gets a Five Hundred Peso (PhP500.00) discount. - Attendance of participants from public schools is on official time only. Those from private schools shall make financial arrangements with their respective offices.
