ONE-DAY REGIONAL CLUSTER ORIENTATION-WORKSHOP OF THE PCs FOR PUBLIC  
SCHOOLS PROJECT-BATCH 3 (PCPS3) RECIPIENT SCHOOLS

1. The Department of Education-Bureau of Secondary Education (DepED-BSE) in collaboration with the Department of Trade and Industry – Office of Special Concerns (DTI-OSC) will conduct the One-Day Regional Cluster Orientation-Workshop of the PCs for Public Schools Project – Batch 3 (PCPS3) recipient schools between June 9, 2006 and June 30, 2006. The schedule of said activity is found in Enclosure No. 1.
2. The above activity aims to: a) orient the school heads on the installation, inspection and acceptance of computer packages to be delivered to recipient schools; and b) enhance instructional leadership skill in managing efficiently and effectively the technology environment in the school.

The travel expenses of the participants in the said activity shall be charged against local funds subject to the usual accounting and auditing rules and regulations; while the travel expenses of the DepED-DTI PCPS3 national coordinator as resource person, and orientation-workshop/training expenses shall be borne by PCPS3 Project funds and Advance Solutions, Inc. (ASI), respectively.
