### STUDENT GOVERNMENT PROGRAM ANNUAL PLANNING AND EVALUATION CONFERENCE

- 1. The DepED-Center for Students and Co-Curricular Affairs (CSCA) will conduct the Student Government Program Annual Planning and Evaluation Conference on September 15-18, 2006 at the Boso Boso Highlands, Antipolo City.
- 2. This annual conference aims to achieve the following objectives:
  - a. Evaluate the Student Government Program (SGP) implementation, including the conduct of the 4<sup>th</sup> National Leadership Training for Student Government Officers (NLTSGO);

b. Identify and resolve issues and concerns pertinent to the SGP implementation and the conduct of the 4th NLTSGO;

c. Discuss the implementation of the Thrusts and Activities of the SGP for School Year 2006-2007;

d. Discuss programs, projects and ways in harnessing the student government as an effective partner in achieving quality education and academic excellence in schools; and

e. Improve efforts in making available real exposure, experience and learning in responsible and participative democracy and leadership.

- 3. Participants to this evaluation and planning conference are the Secondary Education Division Araling Panlipunan Regional Supervisors or the Regional Coordinators in-charge of the Student Government Program or their authorized representatives, officers of the National Federation of Student Government (NFSG), regional student-representatives and DepED-CSCA personnel. Enclosed is the list of participants.
- 4. Participants are expected to be at the venue in the morning of September 15, 2006. The CSCA shall only shoulder board and lodging beginning lunch of September 15, 2006 until breakfast of September 18, 2006.
- 5. Travel expenses and other incidental expenses of participants shall be charged against local funds. Expenses for board and lodging, supplies and materials, including transportation expenses of officers of the National Federation of Student Government and regional student-representatives, shall be shouldered by the DepED-CSCA chargeable against the excess funds generated from the conduct of the 4th NLTSGO.
