SEVENTH ANNUAL CONVENTION OF THE PUBLIC SCHOOLS DISTRICT SUPERVISORS ASSOCIATION (PSDSA)

- 1. The Public Schools District Supervisors Association (PSDSA) will hold its 7th Annual Convention on August 1-3, 2007 at the Manila Pavilion Hotel, United Nations Avenue, Ermita, Manila. The theme is "Educating the Millennial Students: A Challenge to Educational Leaders".
