#### SIXTH YOUTH FOR ENVIRONMENT SUMMER (YES) CAMP

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

- 1. The Department of Environment and Natural Resources-Youth Desk (DENR-Youth Desk), the Kabataang Sama-Samang Maglilingkod (KASAMA), Inc. and the Department of Education-Center for Students and Co-Curricular Affairs (DepED-CSCA) will conduct the Sixth Youth for Environment Summer (YES) Camp on April 28-May 2, 2008 at the Foundation University, Dumaguete City.
- 2. With its theme, "CLIMATE CHANGE: Warming Up the Youth for Global Environmental Activism," the Sixth YES CAMP seeks to achieve the following objectives:
  - a. learn about Climate Change, Global Warming and other related and important environmental concepts that urgently need critical mass action;

b. develop pupils and students' awareness on the state of the environment, focusing on significant issues and concerns;

c. ensure pupils and students' active participation and determined concrete action in the protection, preservation and rehabilitation of the environment and the conservation of natural resources in their respective areas;

d. instill environmental values in every pupil and student to motivate actual involvement in worthwhile programs and projects for the

environment; and,

- e. strengthen the implementation of DepED Order No. 72, s. 2003 on the "Establishment of the Youth for Environment in Schools Organization (YES-O)" and DepED Memorandum No. 254, s. 2007 on the "Thrusts and Activities of the Youth for Environment in Schools Organization (YES-O)."
- 3. Activities during the Sixth YES CAMP include interactive and fun plenary sessions, break-out sessions, field exposures, outdoor activities and contests, such as essay-writing, on-the-spot poster-making, slogan-making, SAYAWIT (Sayaw at Awit sa Kalikasan), quiz bee, spelling bee, Search for the Lakambini and Lakan ng Kalikasan, YES-O Exhibits and Spotlight featuring YES-O success stories on environmental action and initiative. Exciting prizes await winners in the contests, particularly in the YES-O Exhibits and YES-O Spotlight. The Camp features new and exciting activities such as, but not limited to, Environmental Films Festival, Tree Planting and the Munting Bayani ng Kalikasan Awards.

- 4. Since the environment is everyone's concern, the participants to this camp are officers and members of the Youth for Environment in Schools-Organization (YES-O), Supreme Student Government (SSG), Supreme Pupil Government (SPG), Student Technologists and Entrepreneurs of the Philippines (STEP), Youth Entrepreneurship and Cooperativism in Schools (YECS), Science and Environmental Clubs, Boy Scouts and Girl Scouts of the Philippines, Campus Paper Editorial Staff, Sangguniang Kabataan (SK), and all other school-based clubs or organizations. Teachers, Advisers, School Principals, Education Supervisors, District Supervisors and other education officials from the different public and private elementary and secondary schools nationwide are also authorized to attend.
- 5. A registration fee of Four Thousand Two Hundred Pesos (PhP4,200.00) only shall be charged each participant to cover accommodation and meals from dinner of day 0 to breakfast of day 4, training kits, certificates, reproduction of modules, speakers' honoraria, T-shirts and bags and other incidental expenses of the camp, chargeable against local funds/local school board funds, or sourced from private organizations or the Local Government Units.
- 6. Members of the DepED National Organizing Committee and the Secretariat are authorized to travel three (3) days before the start and two (2) days after the YES CAMP.
- 7. Regional Directors, Schools Division Superintendents and School Principals are encouraged to send participants to the Sixth YES CAMP.
- 8. The schedule of activities, contest guidelines and the members of the DepED Organizing Committee and Secretariat are enclosed as Enclosure Nos. 1, 2 and 3 respectively.

#### Youth for Environment Summer (YES) Camp Contest Guidelines

#### I. General Guidelines

- 1. The contest is open to all registered participants to the YES Camp.
- A participant is qualified to compete in any contest, whether individual or group, provided he/she
  duly registers and, provided further, there is no conflict in the schedule.
- Participants are only allowed to join their respective educational level, that is, elementary pupils are only allowed to join contests identified for the elementary level and high school students are only allowed to join contests identified for the secondary level.
- 4. Contestants shall indicate their contests of interest in the Pre-Registration Form or Verification Form. In any case, contestants shall also be required to fill up the Contest Registration Form (CRF) and submit the same to the Secretariat during DAY O immediately after the general camp registration.
- 5. As a rule, an elimination round shall be conducted.
- 6. There shall be a contest briefing 15 minutes before the contest proper.
- 7. Decisions of the Board of Judges are final.

#### II. Specific Guidelines

#### A. On the Spot Poster-Making Contest (Individual, Elementary and High School Levels)

- Only one (1) contestant per school shall participate in the contest.
- 2. The poster should revolve around the theme which will be announced by the contest administrator during the contest proper.
- 3. The medium for visual artistry shall be water color only. The required base paper to be used during the contest, however, is an illustration board.
- All materials will be provided by the organizers. Borrowing of materials from other contestants shall not be allowed.
- 5. The allotted time for the contest is one and a half (1 1/2) hours, after which all entries shall be submitted to the contest administrator. Contestants may decide to submit his/her poster earlier without waiting for the lapse of one and a half (1 1/2) hours. Late submission shall be deducted 1% from the total for every extension of five (5) minutes. A fraction of five (5) minutes shall already be considered five (5) minutes for purposes of the deduction.
- 6. Each poster shall be identified by a number that corresponds to the number and identity of the contestant for the judging process.
- 7. Judging shall be based on the following criteria:

Originality of Idea 40%
Relevance to the Theme 40%
Overall Impact 20%
Total 100%

#### B. Slogan-Making Contest (Individual, Elementary and High School Levels)

- 1. The contest is open to a maximum of three (3) contestants per school.
- 2. Only one entry per contestant is allowed.
- 3. The slogan should revolve around the environmental theme, which will be announced by the contest administrator during the contest proper.
- 4. The slogan shall be in Filipino (national language), which must be catchy, simple and clear.
- 5. The slogan shall consist of five to ten (5-10) words only. A compound word will be considered as one word, example *kapit-kamay*.
- 6. The material to write on shall be provided by the organizers. Contestants shall bring their own felt tip marking pen.
- 7. The allotted time for the contest is one (1) hour, after which all entries shall be submitted to the contest administrator. Contestants may decide to submit his/her slogan earlier without waiting for the lapse of one (1) hour.
- 8. Each slogan shall be identified by a number that corresponds to the number and identity of the contestant for the judging process.

9. Judging shall be based on the following criteria:

Originality/Freshness of Idea	40%
Relevance to the Theme	40%
Overall Impact	20%
Total	100%

#### C. Environmental Spelling Bee (Individual, Elementary Level Only)

- 1. All elementary level student-campers are eligible to join this contest provided there is no conflict in the schedule as regards their participation in other contests.
- Only twenty (20) student-campers shall qualify in the finals. To determine the finalists, an elimination round shall be conducted, the result of which shall be announced during plenary sessions and posted in the secretariat. The elimination round shall be in the form of a written examination consisting of easy, average and difficult words.
- 3. The finals will be an oral competition consisting of easy, average and difficult words. Each student-contestant shall be required to spell a word at a time. Failure to spell two words will automatically disqualify the contestant until the top five contestants or less are left who shall be declared the winners. The contestant shall be given a maximum of one (1) minute within which to start spelling the given word.
- 4. Words to be spelled shall be related to the environment and current events. Before the contestant is required to spell, the meaning of the word shall be stated.

#### D. Essay-Writing Contest (Individual, Elementary and High School Levels)

- A maximum of three contestants per school shall be eligible to join the contest.
- It shall be an on-the-spot essay writing contest. As such, the theme/topic shall be announced during the contest proper.
- The essay must be written in English, consisting of not less than 200 words but not more than 300 words, handwritten on a bond paper (A4) provided by the organizers with one-inch margins on all sides.
- The essay should be written legibly in black or blue ink only.
- 5. Contestants shall be given one (1) hour to complete their essay. They shall not be allowed to leave the contest venue once the contest has officially started.
- The contest administrator shall decide if an elimination round is proper and necessary.
- 7. Criteria for judging shall be based on the following:

Content 40%
Relevance to the Theme 30%
Unity/Organization of Idea 15%
Grammar 15%
Total 100%

#### E. Environmental Quiz (Individual, High School Level Only)

- All high school student-campers are encouraged to participate in the Quiz provided they are in the venue before the start of the contest.
- 2. English and Filipino shall be used as the official languages in the conduct of the quiz.
- 3. Questions shall focus on environmental facts, laws, current events, initiatives and other subjects pertaining to the environment and ecology.
- 4. Each question shall be read twice by the quizmaster. The contestants shall only answer as soon as the quizmaster shall have read the question twice and have so indicated their time to write the answer in big bold letters. Countdown shall start immediately thereafter.
- 5. Contestants shall be given a maximum of twenty (20) seconds to answer questions that require computation. Other questions shall only be allotted ten (10) seconds.
- 6. The contestants shall bring their own pens, answer sheets shall be provided by the organizers. Should the contestant decides to change an answer, he/she shall cross out the answer so written with only one horizontal line and the new answer shall be written legibly above the crossed out answer. The contestant is allowed to change answer within the time allotted for a particular question.
- 7. The contestants shall raise their pens as soon as the allotted time to answer is over.
- 8. If applicable, depending on the number of entries, an elimination round shall be held.
- During the elimination round, failure to answer seven out of ten questions correctly shall disqualify and eliminate the contestant. The elimination round shall involve easy, average and difficult questions.

- 10. For the elimination round, only twenty (20) or less qualifiers shall advance to the finals regardless of school, division or regional membership.
- During the finals, there shall be a total of thirty (30) questions to be given for three rounds, ten (10) of which for the easy round, ten (10) for the average round and another ten (10) for the difficult round.
- 12. For the easy round, one (1) point shall be given for each correct answer, two (2) points for every correct answer for the average round; and three (3) points for each correct answer for the difficult round.
- The five highest scoring contestants shall be declared the winners.

## F. SAYAWIT-Sayaw at Awit Para sa Kalikasan (Group, High School Level Only)

- 1. A minimum of five (5) and a maximum of twenty (20) participants shall perform during the contest.
- Dancers and singers shall be considered as performers.
- 3. The performance must consist of a song and dance presentation on the environment. Participants must actually sing and dance at the same time. Any song in English, Filipino or any dialect may be used, or a combination thereof may be utilized.
- 4. The presentation should last for a maximum of eight (8) minutes, in which period shall be included the introduction and the exit of the performers.
- 5. The presentation shall be stopped when time is up.
- 6. Musical accompaniment for the presentation may either be cassette tape or compact disc-generated only. No live accompaniment shall be allowed.
- The presentation must have environmental relevance and significance.
- 8. Props should be at the minimum only.
- Only one (1) group shall represent a school.
- 10. Depending on the number of entries, an elimination round shall be held. Only twelve (12) entries shall qualify for the finals.
- 10. There shall be a different set of Board of Judges during the elimination and the final round.
- Judging shall be based on the following criteria:

Environmental Relevance/Message 30%
Voice Quality 20%
Precision of Dance Movements 20%
Originality 20%
Projection and Overall Impact 10%
Total 100%

## G. YES-O Exhibits (Group, High School Level Only)

- 1. The exhibits should touch on the school-based YES-O's implementation of environmental projects as mandated in the YES-O's constitution and by-laws. It shall also feature the organization's plans and success stories on environmental action and initiative.
- 2. The exhibits shall consist of pictures appropriately labeled, certifications, approved and implemented project proposals, publications, reports, write-ups and other materials that comply with number 1.
- 3. The organizers shall only provide two (2) manila papers measuring 3 feet x 4 feet each on which the exhibits shall be mounted.
- Other materials shall be provided by the contestants.
- The exhibits shall be set up during Day O immediately after the registration of participants. Only those registered and members of the school YES-O delegation are allowed to set up the exhibits.
- 6. Participants shall inform the organizers in advance of their interest to join this contest.
- Judging shall be based on the following criteria:

Compliance with YES-O Mandate 80% Design/Appearance of Exhibits 20% Total 100%

### H. YES-O Spotlight (Group, High School Level Only)

- The YES-O spotlight should touch on the school YES-O's implementation of environmental projects as mandated in the YES-O's constitution and by-laws. It shall also feature the organization's plans and success stories on environmental action and initiative.
- The spotlight shall consist of pictures appropriately labeled, video clips, certifications, approved and implemented project proposals, events, publications, reports, write-ups and other materials that comply with number 1.

- 3. The spotlight must be presented using MS PowerPoint Presentation. However, should it require a mix of other applicable programs, the entire presentation should be recorded in DVD format.
- The presentation must be saved in a CD or USB.
- The organizers shall only provide an LCD projector and a computer to be used during the actual
  presentation.
- Depending on the number of contestants, an elimination round shall be conducted.
- 7. Only those registered and who are members of the school YES-O delegation are allowed to present the spotlight in six (6) minutes. No time extension shall be allowed. Once the time has lapsed, the presentation will be stopped. The presenter shall be subjected to questions by the Board of Judges.
- 8. Participants shall inform the organizers in advance of their interest to join this contest.
- Judging shall be based on the following criteria:

Compliance with YES-O Mandate 60%
Design of PowerPoint Presentation 20%
Actual Presentation 20%
Total 100%

#### I. Lakambini and Lakan ng Kalikasan (Individual, High School Level Only)

- 1. The contest is open to all. No regional representation is required.
- The candidates must be registered camp participants.
- 3. There shall be a pre-screening of candidates. Only candidates who have gone through the screening process and approved by the Board of Judges shall be allowed to join in the contest finals. A minimum of twelve (12) pairs shall be chosen to compete in the finals.
- 4. There shall be a different set of Board of Judges during the elimination and the finals.
- The pageant shall consist of three (3) portions, namely;
  - a. Kalikasan Attire Competition
    - (Contestant shall wear creative costumes using indigenous materials.)
  - b. Talent Show
    - (Talent to be presented must have relevance to environmental awareness or cause.)
  - c. Question and Answer
    - (The questions to be answered must have relevance to the environment.)
- Judging shall be based on the following criteria:

Beauty and Personality 30%
Talent and Execution 25%
Intelligence and Wit 25%
Stage Presence 10%
Overall Impact 10%
Total 100%

#### J. Munting Bayani ng Kalikasan Awards (Individual, Elementary and High School Level)

- 1. The award is open to all YES Camp registered participants.
- Upon registration, applicants for the awards shall submit an essay on why he/she deserves to be included in the roster of young environmental heroes. The essay (at least 300 words) must be supported by properly labeled evidence such as appropriate and duly authenticated certificates, pictures, audio-visual presentations and others.
- 3. The applicant shall be subjected to a panel interview.
- Judging shall be based on the following:

Essay/Supporting Evidence 40%
Panel Interview 40%
Overall Impact 20%
Total 100%

Note: Cash Prizes and Trophies shall be awarded to all individual and group competitions,

#### PRE-CAMP PREPARATION

#### Pre-Registration Requirement

To ensure your participation, please secure a copy of the attached Pre-Registration Form (PRF). Kindly fill it up and send and/or fax in the PRF to the Center for Students and Co-Curricular Affairs (CSCA) at (02) 631-8495 or 636-3603 on or before April 15, 2008.

#### TRAINING PROPER

#### Arrival of Participants/Registration

Participants are expected to arrive on April 28, 2008. Upon arrival, please proceed to the Registration Hall for the verification, payment, distribution of kits and billeting assignments.

Advance on-site registration starts on April 27, 2008 at 9:00 AM.

#### **Payment**

Payment in cash is preferred. Payment in check shall be made payable to the Kabataang Sama-Samang Maglilingkod (KASAMA), Inc. No personal checks shall be honored.

#### **Billeting and Accommodation**

Accommodation shall start in the morning of April 28, 2008 and end in the morning of May 2, 2008. Charges for advance and extended accommodation shall be for the account of the participants.

#### Meals

#### REGISTRATION PROCEDURE

- 1. Only the REPRESENTATIVE of the school, division or region, if delegation is by school, division or region respectively, shall transact business with the REGISTRATION COMMITTEE.
- 2. Upon arrival, proceed to the Verification Counter with your list of delegation duly written on the Pre-Registration Form (PRF) in four (4) original copies. If you fail to bring the PRF, please secure one (1) set of the Verification Form (VF). VF consists of four (4) copies, namely, SECRETARIAT'S COPY, CASHIER'S COPY, BILLETING COMMITTEE'S COPY and PARTICIPANT'S COPY. Fill up the VF with the names and other pertinent information of your delegates.
- 3. Present your four (4) copies of the Pre-Registration Form (PRF) or your accomplished Verification Form (VF) to the personnel assigned to your Region at the Verification Counter for verification. The personnel assigned shall stamp all four (4) copies of your PRF or VF with the word "VERIFIED". The Verification Counter shall get the SECRETARIAT'S COPY of the PRF or VF for record purposes.
- 4. DO NOT LOSE YOUR PARTICIPANT'S COPY. Only the Participant's Copy shall be used to claim the kits, meal tickets, IDs, bags, hand-outs, shirts, certificates and other training collaterals.
- 5. Pay to the CASHIER. Upon payment, an official receipt shall be given and the three (3) remaining copies of the PRF or VF shall be stamped "PAID" and signed. The Cashier shall get the CASHIER'S COPY of the PRF or VF for record purposes.
- 6. Present your remaining copies of the PRF or VF to the Billeting Committee Counter for assignment of quarters. The Billeting Committee shall stamp your PRF or VF with the word "BILLETED" and get the Billeting Committee's Copy of your PRF or VF.
- 7. Upon assignment of billeting quarters, proceed to the RELEASING COUNTERS for the bags, shirts, kits, meal tickets, IDs, and others. The personnel assigned shall stamp "ISSUED" on your PRF or VF Participant's Copy once the camp collaterals have been given. Please countersign on a separate form upon receipt of the camp collaterals.
- 8. Proceed to the Contest Registration Booth. Get a copy of the Contest Registration Form (CRF) and fill it up. Submit/Return the CRF immediately to the booth duly filled up and signed by the contestant himself/herself indicating the contest of interest. Only those who submitted their CRF on DAY O shall be allowed to join the contest.
- 9. By now, you are through with the registration procedures. Please prepare for the next activity as indicated in your schedule of activities.
