SECOND PAVEA NATIONAL CONGRESS

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Secondary Technical-Vocational Schools

1. The Philippine Association of Vocational Education Administrators (PAVEA) in coordination with the Bureau of Secondary Education and Technical-Vocational Task Force will hold its **Second National Congress of Technical-Vocational School Administrators** at the Bohol Plaza Resort and Restaurant at Panglao Island, Dayo Hill, Mayacabac, Dauis, Bohol on February 25-27, 2008 with the theme *"The Role of Technical-Vocational Schools on the Socio-Economic Development of the Community."*

2. The congress aims to:

- a. assess the implementation of the Strengthened Technical-Vocational Education Program and determine the extent to which it provides the technical-vocational students with the competencies needed for good citizenship;
- b. address issues and challenges regarding technical schools, secondary school management, administration, budgeting, civil service, finance and policy-legislation;
- c. update the participants on the programs and projects involving technical-vocational schools initiated by the organization and the Tech-Voc Task Force; and
- d. provide the participants trainings on action research and publication specially on technical-vocational education programs and projects.

3. The participants in the congress are Schools Division Superintendents/Assistant Schools Division Superintendents (SDS/ASDS) with public technical and vocational high schools in their Division, Chiefs, Secondary Education Divisions, Regional and Division Supervisors of Technology and Livelihood Education/Technical and Vocational Education (TLE/TVE) subjects, Heads of General Public Secondary High Schools, Private Schools, Vocational School Administrators, Principals and Officers in-Charge of Public and Private Secondary Technical-Vocational (Agriculture, Fishery, Trade and Home Industry) Schools, Head Teachers of academic and vocational departments, and one (1) Vocational Teacher who handles a viable Income-Generating Project.

4. Teacher-participants may swap their time schedules with other teachers in the school to avoid disruption of classes. They can then offset their absence in class with the same number of class hours upon their return from the congress.
5. A registration fee of Five Thousand Pesos (PhP5,000.00) shall be charged each participant to cover expenses for board and lodging, conference materials and kits, honoraria of speakers, facilitators, etc. Traveling expenses and registration fee of participants and committee members shall be charged against office/local school funds subject to its availability and the usual accounting and auditing rules and regulations. Traveling expenses of facilitators from the Task Force on Technical-Vocational Education shall be charged to the Task Force Funds. PAVEA Board of Directors and designated committee members are authorized to travel two days before the congress. Attendance is on **official business**.
6. Participants are advised to register at the Bohol Plaza Resort and Restaurant at Panglao Island, Dayo Hill, Mayacabac, Dauis, Bohol. First meal shall be dinner of February 24 and last meal shall be lunch of February 27, 2008.
