9<sup>TH</sup> PAES NATIONAL CONVENTION

To: Bureau Directors  
Regional Directors  
Schools Division/City Superintendents

1. The Philippine Association of Education Supervisors, Inc. (PAES Inc.) in coordination with the Department of Education (DepED) will conduct the 9<sup>th</sup> PAES National Convention with the theme "ES: Proactive Thinkers and Doers" on April 14-17, 2009 at La Fortuna Hotel, Carbon, Cebu City.
2. The convention seeks to pursue the following objectives:
  - a. increase level of awareness of education supervisors and coordinators on their roles and functions;
  - b. equip education supervisors with the necessary knowledge, skills and attitudes to be effective monitors, evaluators and technical assistants;
  - c. provide a venue for education supervisors to discuss on best supervisory practices and on pressing issues;
  - d. attain a heightened commitment of education supervisors to be SBM advocates and supporters; and
  - e. sustain the strong bond of relationships among PAES members.
3. Participants to this convention are Education Supervisors I and II (Division and Regional Supervisors) and Subject Area Coordinators. Attendance of the supervisors and coordinators shall be on **official business**.
4. A registration fee of Four Thousand Eight Hundred Pesos (PhP4,800.00) will be charged each participant to cover hotel accommodation for 3 days, meals, handouts and other operational expenses. The registration, travel and other related expenses shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
5. Participants are expected to register on April 14, 2009. Since everybody might not be accommodated at the seminar venue, spillovers will be billeted at nearby hotels. First-come, first-served policy will be observed. The first meal will be dinner on Day 0 (April 14, 2009) while the last meal (packed dinner) will be served on April 17, 2009.

PAES officers and committee members are expected to be at the venue one (1) day before and to stay one (1) day after the convention. This is for briefing and evaluation purposes.
