ADMINISTRATION OF THE PHILIPPINE MERCHANT MARINE ACADEMY (PMMA)
SPECIAL ENTRANCE EXAMINATION

1. Due to the calamity that was experienced during the typhoon "Ondoy", the Philippine Merchant Marine Academy (PMMA) will administer its Special Entrance Examination on November 28, 2009 in selected testing centers.

2. The following are the schools to be used as testing centers:

- a. Philippine Merchant Marine Academy, San Narciso, Zambales
- b. Ramon Magsaysay High School, EDSA, Cubao, Quezon City
- c. Tabaco National High School, Tabaco City
- d. Batangas National High School, Batangas City
- e. Cebu City National Science High School, Cebu City
- f. Davao City High School, Davao City
- g. Iloilo National High School, La Paz, Iloilo City
- h. La Union National High School, San Fernando
- i. Misamis Oriental Gen. Comp. High School, Cagayan de Oro (CDO)
- j. Palawan National High School, Puerto Princesa City
- k. Zamboanga City State Polytechnic College, R.T. Lim Boulevard

3. All regional directors, or schools division/city superintendents and principals of public secondary schools to be used as testing centers are encouraged to make these schools and their facilities available during the schedule of the examination.

4. The breakdown of honoraria of personnel (to be shouldered by PMMA) during the conduct of the four (4)-hour entrance examination are the following:

5. Snacks will also be provided to the proctors/principals during the examination. Electrical expenses shall not be shouldered by PMMA during the conduct of the entrance examination. There shall be thirty (30) examinees per classroom.
