10TH ANNUAL CONVENTION OF THE PHILIPPINE ASSOCIATION OF EDUCATION

1. The Philippine Association of Education Supervisors (PAES), Inc. will hold its 10th Annual Convention at Monte Vista Resort, Pansol, Calamba, Laguna on April 5-8, 2010 with the theme "ES: Championing Organizational Diversity thru Servant Leadership".
2. The convention aims to:
 - a. identify national competency standards for Education Supervisors I and II;
 - b. enhance their supervisory competence and leadership skills in the light of DepEd policies and programs;
 - c. attain a heightened commitment in providing technical assistance to the field for the full implementation of SBM; and
 - d. strengthen and sustain the bond of relationship among PAES members.
3. Participants to this convention are Education Supervisors I and II (division and regional supervisors) and division/regional subject coordinators. Attendance of the supervisors and coordinators shall be on **official business**.
4. A registration fee of Four Thousand Eight Hundred Pesos (PhP4,800.00) will be charged each participant including members of the working committees to defray expenses for three (3) days hotel accommodation, meals, honoraria of speakers, convention kits and other operational expenses. Traveling expenses and registration fee shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
5. Participants are expected to register in the afternoon of February 23 (Tuesday). First meal shall be served in the evening of the said date and the last meal is on February 26, 2010 (Friday).
6. All PAES Officers and Board Members are expected to arrive at the venue on February 22, two days before the start of the convention (February 23, 2010) for the convention preliminaries and are to leave the day after the activity. Enclosed is the schedule of activities.
