

- May be still in active service, retired or diseased;
- Must have created an impact on a Filipino community in terms of at least

five of the following aspects of achievement:

- a. research yielded;
- b. number/quality of achievers trained;
- c. number of learners served
- d. one or more significant ideas initiated;
- e. actively involved in unpublicized literacy project
- f. has published professional articles on literacy and reading education;
- g. has wide extension work in reading/literacy education;
- h. has helped raise the qualitative standards of achievement/service.

When nominee is an INSTITUTION, it:

- May be nationally or internationally based but serving the Philippines/ Filipinos;
- Must have been in active operation within the last five years;
- Must have had professional impact on a Filipino community based on five of the Aspects a to h under the criteria for individual nominees.

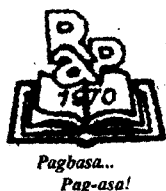
