# TRAINING-SEMINAR ON REPUBLIC ACT NO. 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) FOR PROCUREMENT PRACTITIONERS IN PUBLIC SECONDARY SCHOOLS

To: Schools Division/City Superintendents Heads, Public Secondary Schools Vocational School Superintendents All Others Concerned

1. In line with the Department of Education's thrust to promote transparency, competitiveness, accountability and efficiency, the National Association of Public Secondary Schools of the Philippines (NAPSSPHIL), in coordination with the Bureau of Secondary Education (BSE) and in partnership with the DepEd-Procurement Service (DepEd-PS) will spearhead the conduct of a two (2) - cluster Training-Seminar on Republic Act No. 9184 and its Implementing Rules and Regulations (IRR) for Procurement Practitioners in Public Secondary Schools on August 28-29, 2010. Please see table below and Enclosure No. 1 for program of activities:

- 2. The capacity building on procurement in the field will ensure that the single set of procedures and processes pursuant to R.A. No. 9184 will be implemented to avoid unnecessary wastage brought about by misinterpretation of the law. There is also a need to retool and continuously update the procurement practitioners in the field with the latest issuances of the Government Procurement Policy Board (GPPB) and amendments in the IRR of R.A. No. 9184, which shall be explained by the DepEd-PS officials/personnel.
- 3. Each secondary school shall have the following participants:
  - a. Head of Procuring Entity (HOPE);
  - b. One (1) member of the Bids and Awards Committee (BAC), preferably the Chairperson;
  - c. One (1) member of the BAC Secretariat; and
  - d. Supply Officer.
- 4. A registration fee of Three Thousand Pesos (PhP3,000.00) which shall be chargeable against school fund **subject to its availability** shall be collected from each participant to cover board and lodging, training materials, handbook on R.A. No. 9184, transportation and per diem of the facilitators and resource speakers, and other related seminar expenses and the usual accounting and auditing rules and regulations.



- 5. First meal shall be A.M. snack on Day 1 (August 28, 2010) and the last meal shall P.M. snack on Day 2 (August 29, 2010). Registration and check-in of the participants shall be at 8:00 a.m. on Day 1 and check-out shall be at 2:00 P.M. on Day 2.
- 6. To facilitate hotel accommodation, all concerned are requested to confirm their attendance using the slip in Enclosure No. 2 and to deposit their registration fee with any branch of Banco de Oro nationwide to NAPSSPHIL savings account no. 5040125608 and fax the deposit slip to Mr. Warlito D.
