2010 GIGANTIC COLGATE SACHET CHRISTMAS DECORATION MAKING CONTEST

- 1. The Department of Education (DepEd) through the Health and Nutrition Center (HNC) and Colgate Palmolive Philippines Incorporated (CCPI) announces the conduct of the "2010 Gigantic Colgate Sachet Christmas Decoration Making Contest", as a major highlight of the School Children's Oral Health Awareness Week and School Health Month Celebration in October.

Awarding of prizes for the regional level will be on November 15 and awarding of prizes for the national level shall be on November 24, 2010.

- I. Objective of the Contest:
 - 1. Create awareness on the importance of regular brushing with fluoride toothpaste;
 - 2. Promote care for the environment by recycling used toothpaste sachets.
 - 3. Enhance creativity and team work among the school children.
 - 4. Supplement existing health equipment and IT tools to the school health and nutrition offices.
- II. What is the theme?

Christmas-inspired craft using recycled Colgate Toothpaste Sachets


III. Who may join the contest?

All public elementary schools nationwide are encouraged to participate in the creation of the Division entry.

IV. What will be the size of the Division entry/creation?

Entry size should be at least:

Height 8 feet
Length 6 feet
Width (front to back) 6 feet



Each entry must make use of at least 3,000 pieces of Colgate Sachets

- V. How will the Division entry/ creation be submitted?
 - The Division shall come up with/create 1 entry which may be a one whole structure or one with several parts/figures.
 - The Division shall submit to the Regional Office colored pictures (size- 11 inches x 8 inches in 5 angles)
 - The Division must maintain and preserve their entry until final judging of the national winners.

Entries shall be judged on the following criteria:

1.	Creativity/Originality	30%
2.	Usefulness	25%
3.	Workmanship	20%
4.	Brand Visibilty	10%
5.	Extent of use of Colgate Sachets	15%

VIII. How will the entries be created?

The Division Office, through the Health and Nutrition Section, and selected supervisors, principal and Arts teacher will conceptualize the overall design of the Division entry and assign Christmas decoration figures/parts of the chosen designs/entries to be assembled at designated schools.

It is expected that the DepED Memorandum on the contest shall have been fully disseminated to the schools to ensure the attainment of the contest objectives.

A coordinator among the focal persons of the participating schools will be selected to lead in the creation of the decision entry utilizing the figures/parts/crafts, assigned/submitted by the participating schools.


