CULTURAL STANDARDS FORMULATION**

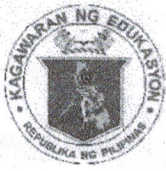

1. The Department of Education Regional Office 02 through the Curriculum & Learning Management Division (CLMD) will conduct a **Regional Training-Workshop on Indigenous Peoples (IP) Cultural Standards Formulation** on March 28-31, 2017 at Bagabag IPed Center, Nueva Vizcaya.
2. The training-workshop is aimed at:
  - a. formulating Indigenous Peoples (IP) Cultural Standards appropriate for every Indigenous Cultural Community (ICC);
  - b. developing well-defined cultural standards as bases for the interfacing of national curriculum with the local competencies of the Indigenous Cultural Communities (ICCs);
  - c. orienting participants on the culture of different ICCs and its implication to classroom instruction and school governance; and
  - d. improving Indigenous Peoples (IP) Elders' participation and awareness to Indigenous Peoples Education Program of the Department of Education
3. Participants to this training are the Division IPed Focal Persons and IP Elders of the different ICCs. Below is the breakdown of IP Elders per Division.

4. First meal to be served will be dinner on March 28, 2017 and the last meal will be pm snacks on March 31, 2017.




