I. CALL TO ORDER

Asec. Revsee A. Escobedo, BAC II Chairperson, presided and called the pre-bid conference to order at 10:58 A.M. The BAC Secretariat documented the minutes of meeting.

II. CERTIFICATION OF QUORUM

The BAC II Chairperson certified that the quorum of the BAC was present to transact business. He acknowledged the presence of the BAC members, BAC

58 Secretariat, Technical Working Group, and observer, and made a roll call of
59 the prospective bidders in the attendance registry.

61 III. HIGHLIGHTS OF DISCUSSION

62 The BAC II Chairperson welcomed everyone to the pre-bid conference.

63
64 The BAC II Chairperson gave a brief description of the project at hand. He
65 asked if invitations were sent to observers and if acknowledged.

66
67 Ms. Jessa B. Buena responded that invitations were sent to the Commission
68 on Audit (COA) and various civil society organizations (CSOs) thru letters
69 dated October 30, 2018 and receipt of invitations was acknowledged through
70 email. She also reported that no bidder purchased Bidding Documents to
71 date. She proceeded with presenting the salient points of the bidding
72 documents.

73
74 Dir. Abram Y.C. Abanil informed the bidders that changes will be made in
75 reference to the lotting of the project. A bid bulletin will be issued regarding
76 the details of dividing the project into two lots, its delivery period and other
77 incidentals to the changes.

78
79 Mr. Boggs Pineda from Mislal asked for the required bandwidth for the
80 project. Dir. Abanil stated that as per technical specifications, peak
81 information rate is 5Mbps.

82
83 The following issues raised by prospective bidders will be addressed through
84 bid bulletin as advised by the BAC II, to wit:

- 85 1. Details of aggregate contracts in reference to the single largest completed
86 contract (SLCC); whether the maximum number of aggregate contracts is
87 two (2) and what is the required percentage of the latter from the ABC of
88 the lot to be bid.
- 89 2. Missing price schedule for services since only the price schedule for
90 goods is provided in the bidding documents
- 91 3. Contract Duration
- 92 4. Post-qualification documents if a foreign bidder
- 93 5. Set-up for the DepEd Central Office if will be separated as different lot

94
95 Mr. Angelo Mercado from PLDT clarified on the submission of tax clearance
96 if bidder opts to submit Class "A" documents in lieu of PhilGEPS Platinum
97 membership to be presented during post-qualification. The BAC
98 Chairperson responded that tax clearance should be submitted with all the
99 enumerated Class "A" documents.

101 Mr. Florante Cruz from BC Net, Inc. asked the possibility of extension for
102 the deadline of submission of bids. The BAC responded that the challenge
103 in this project is to obligate the funds allotted before the end of the fiscal
104 year, so the extension for the deadline of submission of bids is not yet
105 entertained.

107 The BAC reminded the prospective bidders to write a clarification letter
108 which may be sent via the BAC Secretariat e-mail address on or before
109 November 9, 2018, 5:00 P.M.

111 Having no other matters to discuss, the pre-bid conference was adjourned at
112 11:33 A.M.




