

DATE : January 20, 2017

The Bureau of Learning Delivery through the Student Inclusion Division (BLD-SID) will conduct the **Orientation-Seminar for Alternative Learning System (ALS) Coordinators/Facilitators on Handling Children in Conflict with the Law** on the following dates and venues: **February 21-24, 2017** at Dipolog City for Batch 1-Visayas and Mindanao Cluster and on **March 6-9, 2017** at Baguio City for Batch 2-Luzon Cluster, exclusive of travel time.

The Orientation-Seminar aims to provide the participants with the information on psycho-social intervention including resources and support in handling students-at-risk (bullying, abuse, discrimination, exploitation, violence) and in-conflict with the law.

The activity shall be attended by Regional and Division Focal Person, and District ALS Coordinators/Mobile Teachers. Traveling expenses, board and lodging of participants shall be charged against 2016 ALS Funds subject to the usual government accounting and auditing rules and regulations. The participants are advised to purchase the most reasonable mode of transportation, and that reimbursement shall be made only at the venue upon submission of the approved travel authority, original bus or plane tickets and other necessary document.

The Regional Offices are hereby requested to submit the list of participants who will be attending the activity. The allocation on the number of participants per Region and Division is attached as Annex A. For strict compliance, the list must be submitted through e-mail at bld.sid@deped.gov.ph on before February 10, 2017.
