This activity aims to validate the MFAT for further enhancement. The screening tool will be utilized to determine the strengths and weaknesses of learners at the early grades as basis for designing appropriate educational interventions and placement.

During the orientation, assessors are requested to bring their own laptop and extension cord for use during the hands-on activities. First meal is breakfast on **March 21, 2017** and last meal is afternoon snacks on **March 22, 2017**.

MFAT shall be pilot tested in the schools of the assessors on March 23-24, 2017.

Expenses relative to the conduct of the said activity such as board and lodging, travel expenses of the assessors/facilitators, and materials preparation, reproduction and retrieval shall be charged against BLD-SID funds subject to the usual government accounting and auditing rules and regulations. Payment of traveling expenses shall be reimbursed after submission of complete travel documents.
