In compliance with the letter from the Office of the Dr. Edel B. Carag, Director III and OIC-Director IV of the Bureau of Learning Resources, dated July 14, 2017, this advisory is issued for the information of the Schools Division Superintendents.

REGIONAL CLUSTER TRAINING-WORKSHOP FOR POTENTIAL LEARNING RESOURCE EVALUATORS (LREs)

- 1. The Department of Education Bureau of Learning Resources (BLR) will conduct the Regional Cluster Training-Workshop for Potential Learning Resource Evaluators (LREs) at Ecotech Center, Escario St., corner Gorordo Ave., Cebu City on July 30-August 3, 2017.
- 2. This activity is in preparation for the evaluation of learning resources for learning areas in the following areas in the following key stages of learning: a) Kindergarten to Grade 3; b) Grades 4 to 6; Grades 7 to 10; and d) Grades 11 to 12. The training-workshop aims to train the qualified LREs for them to become more conversant on the evaluation processes of learning resources.
- 3. The participants to this activity are those who **Passed** in each key stage per learning area during the validation of documents conducted by the Central Office Screening Committee (COSC) which is found in the attached document.
- 4. They are expected to check-in in the afternoon of July 30, 2017 and check-out in the afternoon of August 3, 2017. The first meal is dinner on July 30, 2017 and last meal is lunch on August 3, 2017. They should bring their signed Authority to Travel and other documents needed.
- 5. All expenses of the participants such as the transportation, per diem, board and lodging shall be charged against the BLR funds. The travel expenses of the participants shall be reimbursed upon submission of the complete documents needed subject to the usual accounting and auditing rules and regulations. Relative to this, the participants **must observe** the cheapest means of transportation.
- 6. The Program of Activities is likewise attached for reference purposes.


