The Teachers' Dignity Coalition (TDC) will be holding the **National Seminar on DepEd Policies and Legal Process** on March 3-5, 2017 at Angela's Pool Resort, Bgy. San Jose, Puerto Princesa City, Palawan. With the theme "**Teachers' Empowerment through Legal Education**" the seminar aims to educate the teachers and school heads on their rights and responsibilities and their contribution to strengthen the DepEd legal processes.
