INVITATION TO BID

FOR THE

Procurement of Sports Uniforms and Caps, and Sports Supplies and Materials for the Conduct of 2019 Palarong Pambansa

1. The Department of Education (DepEd), through the Government of the Philippines (GOP) under FY 2019 General Appropriations Act (GAA), intends to apply the sum of Philippine Pesos Six Million Eight Hundred Sixty-Seven Thousand Eight Hundred Sixty-Six and 18/100 (Php 6,867,866.18), being the Approved Budget for the Contract to payments under the contract for Procurement of Sports Uniforms and Caps, and Sports Supplies and Materials for the Conduct of 2019 Palarong Pambansa, broken down in lots as follows:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. DepEd, through its Bids and Awards Committee 2, now invites bids for the goods and services contemplated in this project and as detailed in the Schedule of Requirements and the table of Technical Specifications indicated in the bidding documents. Expected completion of delivery should not be later than the 2nd week of April 2019 at Davao City National High School, Davao City. Bidders should have completed, within five (5) years immediately preceding the deadline for the submission of bids, at least two (2) contracts similar to the Project, the aggregate applicable contract amount being equivalent to at least fifty percent (50%) of the ABC of the lot bid for, and the largest of those said contracts is equivalent to twenty-five percent (25%) of the said ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

The issuance of bidding documents shall be from February 25, 2019 during office hours to March 18, 2019, 9:00 A.M. at DepEd-ProcMS, Room M-511, 5/F, Mabini Building, DepEd Complex, Meralco Ave., Pasig City

- 6. The DepEd will hold a Pre-Bid Conference on March 4, 2019, 9:00 A.M. at Procurement Management Service Conference Room, Rm. 418, 4/F, Mabini Bldg., DepEd Complex, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 A.M. of March 18, 2019 at Procurement Management Service Conference Room, Rm. 418, 4/F, Mabini Bldg.. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *March 18, 2019, 9:00 A.M.* at *Procurement Management Service Conference Room, Rm. 418, 4/F, Mabini Bldg.*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. DepEd reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
