(Revised Signing Authorities for Financial Matters)

- This DepEd Order (DO) amends portions of DO 67, s. 2016 entitled Revised Signing Authorities for Financial Matters and DO 16, s. 2018 entitled Implementing Guidelines on the Release and Use of Funds for Fiscal Year 2018, which shall apply only with regard to the signing authorities in the Internal Audit Service (IAS) and International Cooperation Office (ICO).
- 2. This Order shall serve as the basis for the signing authorities on the abovementioned transactions made by IAS and ICO considering that these offices are under the direct supervision of the DepEd Secretary.
- As provided in this Order, IAS and ICO shall abide to the following signing authorities for certain transactions as follows:

b. Activity Request and Authority to Conduct Activities

i. Activities, which conform to the approved WFP, Monthly Disbursement Program (MDP) and Annual Procurement Plan (APP), may proceed through an Activity Request (AR) with the approval of these offices' Director or higher official.

ii. If the activity is not in the approved WFP, MDP and APP, an Authority to Conduct (ATC), as agreed, is required in order for the activity to proceed. Approval of the ATC shall now be given by the following officers:

- c. Purchase Request, Authority to Procure Goods and Services, and Infrastructure Projects and Consultancy Services
 - i. Procurement of goods and services, infrastructure projects and consultancy services shall still conform with the provisions of Republic Act No. 9184, otherwise known as the **Government Procurement Reform Act**.
- ii. The approval of the Purchase Request/Authority to Procure goods and services, infrastructure projects and consultancy services for IAS and ICO shall be given by the following officers:
