55 The BAC I Chairperson certified that the quorum of the BAC was 56 present to transact business. He acknowledged the presence of the 57 BAC members, BAC Secretariat and observer, and made a roll call of 58

the prospective bidders in the attendance registry.

III HIGHLIGHTS OF DISCUSSION

The BAC I Chairperson welcomed everyone to the pre-bid conference. Mr. Jose Antonio Flores, BAC Secretariat, read out the key points of the project and important sections of the Bidding Documents such as the Approved Budget for the Contract (ABC), Instructions to Bidders, Special Conditions of the Contract, Schedule of Requirements, Technical Specifications and the deadline for submission and opening of bids.

The BAC I Chairperson opened the floor for queries.

The BAC I Chairperson noticed that the Approved Budget for the Contract for Lot 2 is relatively high. He asked the prospective bidders if they are willing to bid for Lot No. 2 considering the amount. Ms. Lilibeth Manabat (Book Media Press, Inc.) and Ms. Jessica Pineda (Studio Graphics Corporation) said they were.

The BAC I Chairperson suggested disaggregating Lot No. 2 per region. Ms. Lilibeth Manabat (Book Media Press, Inc.) commented that if Lot No. 2 will be disaggregated per region, it may incur larger cost. The BAC I Chairperson stated that the BAC will have to further review this matter and for the bidders to expect a reposting of this project if the ABC will be changed.

On the Sealing and Marking of Bids, Mr. Flores stated that the bidders may submit a USB in lieu of the CD. The BAC I Chairperson announced that these changes will be included in the bid bulletin.

Ms. Manabat (Book Media Press, Inc.) also requested to identify the colors of the inside pages in the Technical Specifications. She also requested for the allocation lists for this project to be provided. The BAC I Chairperson stated that they will have to check on this matter and instructed the BAC Secretariat to include the allocation list in the bid bulletin. The BAC Secretariat concurred.

Ms. Manabat also asked for clarification on page 37 of the Bidding Documents, specifically ITB Clause 27, Domestic Preference. She shared that they have tried getting a certification of domestic preference from Department of Trade of Industry but failed to secure one because DTI said that they do not issue such certification.

The BAC I Chairperson reviewed ITB Clause 27.1 and 27.2 and discussed it with the prospective bidders. The BAC I Chairperson

requested for Ms. Manabat to formally write DepEd about their 104 105 experience with DTI so that the DepEd can help them address the 106 issue. 107 108 The BAC I Chairperson gave a rundown of the issues raised and items that need to be clarified.
