INVITATION TO BID FOR PROCUREMENT OF INTERNET SERVICES FOR DEPED

1. The *Department of Education (DepEd)*, through the *Government of the Philippines (GOP)*, *DepEd Computerization Program (DCP) FY 2018 Fund and DepEd Computerization Program (DCP) FY 2019 Fund under General Appropriations Act (GAA) 2019*, intends to apply the sum of **Philippine Pesos Five Million, Two Hundred Fifty Thousand and 00/100 (Php 5,250,000.00)**, being the Approved Budget for the Contracts to payments under the contract for **Procurement of Internet Services for DepEd**, corresponding to each lot, detailed as follows:

Bidder must bid for all the items in a lot. Bids received in excess of the ABC per lot, and late bids shall be automatically rejected at bid opening. Bidder/s may bid for any or all lots. Bidders bidding for both Lot 1 and Lot 2 will only be entitled for an award to either of the lots bid for. Evaluation and award shall be on a per lot basis, depending on the combination that is most advantageous to the government, in accordance with ITB Clause 1.2 of the Bidding Documents.

2. The **DepEd**, through its Bids and Awards Committee II, now invites bids for the goods and services contemplated in this project and as detailed in the Schedule of Requirements and the table of Technical Specifications indicated in the bidding documents. Delivery of the Goods is required within **Thirty (30) calendar days** from issuance of the Notice to Proceed. The **one (1) year contract duration** shall start upon the issuance of Certificate of Operationality.

Prospective bidders should have completed, within five (5) years immediately preceding the deadline for the submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index, must be at least fifty percent (50%) of the ABC of the lot bid for; OR, at least two (2) similar contracts and the total of the aggregated contract amount should be equivalent to at least fifty percent (50%) of the ABC of the lot bid for; and the largest of these similar contracts must be equivalent to at least twenty-five percent (25%) of the ABC of the lot/s to be bid. The contracts may come from different agencies/companies.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the *DepEd Procurement Management Service at Telephone Nos. 636-6542 or 633-9343* and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the DepEd Procurement Management Service, Room 511, 5th Floor, Mabini Bldg., DepEd Complex, Meralco Avenue, Pasig City, upon accomplishing a bidder’s information sheet and payment of a non-refundable fee for the Bidding Documents to the DepEd Cashier in the amount listed as follows:

It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the procuring entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *DepEd* will hold a Pre-Bid Conference on **September 9, 2019, 10:00 A.M.** at **Administrative Service Conference Room, G/F, Alonzo Bldg., DepEd Complex**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 A.M. of September 23, 2019** at **Administrative Service Conference Room, G/F, Alonzo Bldg., DepEd Complex**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **September 23, 2019, 9:00 A.M.** at **Administrative Service Conference Room, G/F, Alonzo Bldg., DepEd Complex**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated above. Late bids shall not be accepted.

8. DepEd reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
