JOINT CIRCULAR NO. 7-86

TO : ALL HEADS OF MINISTRIES, BUREAUS, OFFICES,

SUBJECT : AUTOMATIC REVALIDATION OF UNUTILIZED CASH
DISBURSEMENT CEILING (CDC) UP TO DECEMBER
31, 1986

- 1.0 While Joint Circular No. 2-84 dated June 29, 1984, as amended, explicitly provides that Cash Disbursement Ceilings (CDC) intended for a certain quarter, shall no longer be used in the following quarter, it is necessary that due consideration be given to releases of CDCs approved and issued from the first quarter of calendar year 1986 to the present, and the positive effect that may result by their utilization.
- 2.0 In view thereof, to provide fund to community development projects and other meritorious projects of the government, pilot ministries under Joint Circular No. 4-86 and 5-86 shall include in their Request for Funding Requirements (RFR) the revalidation of unutilized cash disbursement ceilings issued in the first and second quarters of calendar year 1986 so that the corresponding funding warrants may be issued to them. However, revalidations of CDCs granted for the current year allotment should no longer be included in such RFR.
- 3.0 On the other hand, unutilized cash disbursement ceilings issued to non-pilot ministries in the first, second and third quarters of calendar year 1986 are hereby automatically revalidated up to the end of this year. It is understood that the total effective CDCs for year 1986 shall not exceed the total allotment for 1986.
- 4.0 This Circular shall take effect immediately.
