ADMINISTRATION OF THE YEAR 2003 LICENSURE
EXAMINATION FOR TEACHERS (LET)

Private Elementary and Secondary Schools Principals

1. The Professional Regulation Commission (PRC) and the Board for Professional Teachers (BPT) will administer the Year 2003 Licensure Examination for Teachers (LET), both public and private elementary and secondary levels on August 31, 2003 in seventeen (17) regional/provincial testing centers nationwide.
2. Applications may be filed at the PRC Main Office, PRC Regional Offices in Baguio, Tuguegarao, Lucena, Legazpi, Iloilo, Cebu, Tacloban, Zamboanga, Cagayan de Oro and Davao cities from February 3 to May 31, 2003, and the DepEd Regional Educational Learning Centers/Division Offices in Angeles, Ozamis, Dagupan and General Santos cities from May 19 to 31, 2003, and Butuan and Palawan cities from May 21 to 31, 2003. 3. The DepEd Division Offices or the Regional Educational Learning Centers (RELCs) which will be the filling centers are enjoined to provide a room for the PRC Teams where they will temporarily hold office and receive applications, and to make available their computers and printers, dormitories or home economics building to house or accommodate the teams of proctors and staff during the application and examination periods.
4. All Regional Directors and Schools Superintendents are also enjoined to make available selected public school buildings and facilities as venues of examinations as well as the services of school teachers and other DepEd personnel needed as examination supervisors and room watchers/proctors during the actual conduct of the examination on August 31, 2003. Enclosed is the PRC official announcement.

12. Physical Science (General Science, Chemistry, Physics)


The following are the application requirements:

- (1) Duly accomplished Teachers Application Form (TAF) and Permanent Examination and Registration Card (PERRC);
- (2) Original Birth Certificate issued by the Local Civil Registrar or authenticated NSO Record of Birth and Xerox/photocopies;
- (3) Original and xerox/photocopies of the Transcript of Records with special order number, date of graduation and seal of the school;
- (4) Three (3) identical copies of PASSPORT SIZE picture in plain background with complete name in the tag;
- (5) Two (2) pcs. window mailing envelope with metered postage stamp (1 for Notice of Room Assignment and 1 for the official results).

EXAMINATION FEE is P600.00

APPLICANTS WHOSE NAMES ARE NOT THE SAME WITH THE NAMES APPEARING IN THE BIRTH CERTIFICATES AND TRANSCRIPT OF RECORDS SHALL NOT BE ACCEPTED. THEY WILL BE ADMITTED ONLY UPON SUBMISSION OF AMENDED BIRTH CERTIFICATE FROM THE NATIONAL STATISTICS OFFICE (N.S.O.) OR LOCAL CIVIL REGISTRAR AND CORRECTED TRANSCRIPT OF RECORDS DURING THE APPLICATION PERIOD.

APPLICATIONS WILL NO LONGER BE ACCEPTED AFTER MAY 31, 2003.
