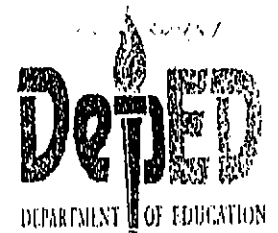

1st NATIONAL SCHOOLS BASKETBALL COMPETITION

To: *Undersecretaries*

1. The DepEd, in cooperation with the Philippine Basketball Association, will conduct the First National Schools Basketball Competition on February 22-28, 2004. The venue will be announced later.
2. Attached hereto are the General Guidelines, Proposed Tournament Format, Team Grouping, Schedule of Games, and List of Technical Officials.
3. Participants are expected to be in Metro Manila in the afternoon of Saturday, February 21, 2004.

1ST NATIONAL SCHOOLS BASKETBALL COMPETITION
GENERAL GUIDELINES

1. All players from the intramural up to the national competition must be enrolled in the schools they represent in the current school year.
2. A player should not be more than 17 years old. The cut-off birth date is January 1, 1987.
3. Players to compose a team should come from one school only. Definitely, the top two winning teams in the regional elimination shall compete in the national level competition.
4. In case a PLAYER of the winning team is injured or incapacitated to play and for any other cause beyond control, said player can be REPLACED only by another player from the SAME SCHOOL and the replacement should be made prior to the start of the tournament.
5. A team may be composed of a maximum of 12 players and 7 team officials (Coach/Asst. Coach, Trainer, Team Manager, Principal, Division PESS Supervisor, and Regional PESS Chief).
6. The team shall have a MONICKER aside from the name of the school to identify them.
7. The Coach/Assistant Coach of a team must be a bonafide school employee.
8. As much as possible, a player must not have more than one(1) failing grade in the first grading period, but definitely, in the second grading period, the NO Failure Policy shall be imposed.
9. Documents to be submitted by individual player and team are:
 - a. TEAM Gallery with 2 x 2 pictures (latest)
 - b. BIRTH CERTIFICATE
 - Certified True Copy (by the LCR) or
 - Certified Xerox Copy (by the LCR)
 - Late Registration must be 1 year before the tournament.
 - c. FORM 137, indicating the grades in previous year level and the Second Grading Period of the current year.
 - d. Parent's Permit
 - e. Medical Certificate

Submit all requirements to DepEd Region IV-A, EED (Attention: Dr. Marietta L. Opulencia). Deadline for submission: February 16, 2004

10. Appreciation of documents by the Screening Committee will be on February 17, 2004 at DepEd Region IV-A.
11. The FIBA rules shall be used in this tournament.
12. Only DepEd personnel who are qualified and/or accredited game officials shall serve as Technical Officials.
13. Residency Rule: A player who transferred during the Provincial/Division Competition will not be allowed to play.

PROPOSED TOURNAMENT FORMAT

1. Participating School Teams

- a. There shall be two (2) teams from each region to participate in the National Competition.
- b. All 40 teams will be divided into 8 groups of 5 teams each.

2. Elimination Round: 80 games (4 days - 3 courts)

- a. Each group will play a SINGLE ROUND ROBIN.
- b. Only the top Team in each group will qualify for the QUARTER finals.
- c. In case of tie, FIBA Rule will be applied.

3. Quarterfinals: 8 teams, 4 games (1 day)

- a. The TOP Teams from each group (8) after the Eliminations shall advance to the Quarterfinals and the qualifiers shall draw lots for groupings (A=4// B= 4)
- b. Each group shall play a SINGLE ROUND ROBIN.
- c. Only the winners will advance.

4. Semi-finals : 2-games (1 day)

- a. Single knockout winners will advance to finals. Losers play consolation game for third place.

5. Finals: 2-games (1 day)

- a. The LOSERS in the semifinals shall play a KNOCKOUT GAME to determine their final rank. (Winner = 3rd place, Loser = 4th place)
- b. The WINNERS in the semifinals shall play a KNOCKOUT CHAMPIONSHIP GAME. (WINNER is champion. LOSER is runner-up.)
