TRAINING WORKSHOP ON THE ART AND PRACTICE OF SUPERVISION: THE SUPERVISOR AS CONSULTANT FOR INSTRUCTIONAL INTERVENTIONS

To: Regional Directors

Schools Division/City Superintendents

- 1. In response to the need of Education Supervisors to continuously upgrade their craft in the art of supervising teachers and assisting them in addressing learning gaps, the Bureau of Secondary Education (BSE) of this Department shall conduct a 4-cluster Training Workshop on the Art and Practice of Supervision: The Supervisor as Consultant for Instructional Interventions.
- 2. The schedule of the training is as follows:

The training workshop aims to enhance the following competencies of supervisors as instructional consultants: a) guide teachers in constructing assessment instruments, and in analyzing and using assessment results as basis for identifying learning needs; b) assist teachers in designing instructional interventions to address learning gaps; and c) conduct progress monitoring as basis for designing capacity-building initiatives for teachers.
- 4. Participants to the workshop are the Secondary Education (SED) Chiefs and Assistant Chiefs, and the Regional and Division Education Supervisors (ES I and II). They are requested to bring the Regional/Division tests in their respective learning areas. Enclosed is the Confirmation Form, which should be submitted one (1) week before the training.
